Buyer Agrees to the Following Terms and Conditions of Sale

1. This Contract and the \$100 deposit applied against the purchase price of a cat/kitten as described herein are binding. If Buyer breaches Contract, the \$100 deposit may be applied against a future purchase based upon the continuance of Katling Cats and/or the availability of kittens for purchase. Any amount deposited in excess of \$100 will be refunded.

If Seller breaches the Contract due to circumstances beyond Seller's control, Buyer will have the option to a) receive a full refund of their deposit, or b) select another kitten based on availability.

2. CFA registration papers (blue slip) will be forwarded to Buyer at the above address within 21 days of sale.
3. Seller guarantees the cat/kitten to be in good health to the best of her knowledge at the time of sale.

The cat/kitten is on approval, for full refund only, for fourteen (14) days from the date of purchase. If Buyer wishes to return the cat/kitten, it may be returned to Seller in the same condition as received.

(a) If the kitten is returned for health reasons, it must be accompanied by a letter from the examining veterinarian explaining the reason for the return. If another cat(s) exists in Buyer's household, a certificate of health must accompany the returned cat/kitten, indicating the existing cat(s) residing in Buyer's household is in good health, current with immunizations, and Feline Leukemia/FIV/FIP negative.

(b) If a health condition is diagnosed, Buyer may elect to treat cat/kitten at Seller's veterinarian and at Seller's cost. If Buyer elects not to use Seller's veterinarian, they will be responsible for all veterinarian bills they may incur, and waive all responsibility from Seller.

(c) If Buyer elects to exchange cat/kitten for another of equal characteristics, this will be considered an even replacement. Previous discounts made to compensate buyer for defects or conditions of the exchanged cat/kitten are not applicable unless present in the replacement kitten. If Seller does not have another cat/kitten available at the time, Buyer agrees to wait for the next breeding to replace cat/kitten.

5. Seller guarantees to Buyer that cat/kitten does not have Feline Leukemia, FIV or FIP.
6. If this cat/kitten should die of a genetic defect within the first three (3) years of life, Seller will offer a replacement cat/kitten based upon the continuance of Katling Cats and/or the availability of kittens for purchase. Buyer also may opt to reserve a replacement cat/kitten from a future litter. This guarantee is valid only upon receipt of a written necropsy report. Seller makes no warranty to provide financial restitution to Buyer for purchase price or any medical costs associated with the health of the deceased cat/kitten beyond the initial fourteen (14) day trial period as stated in Section 4.
7. Under no circumstances will this cat/kitten be sold, leased, given away, or placed with any pet shop, research laboratory or similar facility during his/her lifetime. In the event Buyer can no longer keep cat/kitten, Seller reserves the right to find another suitable pet home, or adopt cat/kitten herself.
8. Buyer agrees to keep cat/kitten indoors at all times.
9. Buyer agrees to provide for health care services by a qualified veterinarian in order to maintain a healthy kitten/adult cat.
10. Buyer agrees NOT to declaw kitten. In the very unlikely event Buyer is unable to control destructive scratching habits, Seller requests a consultation with Buyer to discuss possible remedies. If Buyer opts to declaw their cat/kitten with no discussion or consideration of remedies to alter cat/kitten behavior, Seller will consider this a breach of Contract and cause all warranties to be null and void.
11. Cat/kitten ~~is~~ is not purchased as a breeder.

(a) If cat/kitten is not purchased as a breeder, **Buyer agrees to spay/neuter cat/kitten no later than eight (8) months of age.** A signed statement from the veterinarian or clinic performing the surgery shall be forwarded to Seller as evidence of compliance with this term of contract. If cat/kitten is not spayed/neutered by eight (8) months of age, Seller will consider this a breach of Contract and cause all warranties to be null and void.
12. Other than expressly stated herein, Seller makes no warranties, express or implied, about the quality, characteristics, or fitness of kitten for a particular purpose.
13. The parties acknowledge that this contract was made in the State of New Jersey. If any legal action is instituted, the parties agree that the proper jurisdiction and venue lies in New Jersey, in the county of Camden, and the parties consent to venue and jurisdiction in Camden County, New Jersey.
14. The undersigned are entering into this Contract in good faith, with a clear understanding of and full agreement with all terms and conditions.
